DiGiCo (UK) Ltd., ("DiGiCo or SOUNDTRACS") warrants to the buyer ("the buyer") that all parts (except expendable items, including, but without limitation, faders), of every new audio product, ("Equipment") purchased from it or an authorised DiGiCo or SOUNDTRACS dealer shall be free from defects in materials and workmanship for the period of 12 months from the date of purchase. This warranty is given subject to the following terms:-

DiGiCo or SOUNDTRACS will, at its option under this Warranty, repair or replace any Equipment covered by this Warranty which becomes defective, malfunctions or otherwise fails to conform with this Warranty under normal use and service during the term of this Warranty, at no charge. Any equipment repaired under this Warranty will itself be warranted only for the remainder of the Warranty period of the original Equipment repaired or replaced.

In order to obtain the benefit of Warranty, the Equipment, together with the original or legible copy of the invoice or bill of sale or other date proof-of-purchase document describing the Equipment, must be delivered to the nearest authorised DiGiCo or SOUNDTRACS dealer. DiGiCo or SOUNDTRACS may, at its option, give other directions regarding repair or replacement of defective items.

This Warranty does not cover defects, malfunctions or failures resulting from delivery or transit, accidents, willful damage, negligence, abuse, misuse, operation contrary to furnished instructions, operation on incorrect power supplies, operation with faulty associated equipment, modification, alterations, improper servicing, tampering or unauthorised repair.
